#### Introduction

Allchiefs takes your privacy serious and we shall handle your personal data with the utmost security and care. #### Who is Allchiefs?

Allchiefs is the besloten vennootschap Allchiefs, with registered office at (3013 AK) Rotterdam at Stationsplein 45, registered in the Traderegister of the Dutch Chamber of Commerce under number 71883800.

Allchiefs in its role as controller is responsible with regard to the processing of your personal data.

### How does Allchiefs use your personal data?

Underneath you find an overview of the purposes for the processing of your personal data. We also specify which data we will use for which specific purpose, the legal justification of our processing and how long we will store your data. Please find the information, categorized per purpose.

#### Marketing

Purpose: To send you our newsletter

Information: Email address

Legal basis: Consent

Storage period: Until you unsubscribe

#### Google Analytics

Purpose: Website analytics

Information: IP-address, the pages you visit, the duration of your visit

Legal basis: Legitimate interests of Allchiefs

Interest: Commercial Interest

Storage period: 14 months

### How do we obtain your personal data?

Allchiefs has obtained your data because you have provided this data to us.

## What are your rights?

Under the European General Data Protection Regulation (GDPR) you have certain rights with regard to your data and the processing thereof:



#### Access

You may access your personal information and make any necessary changes in your account. If you would like to see which personal data Allchiefs has obtained about you, you may exercise your right of access by submitting a request to Allchiefs.

### Making changes

If you wish to make changes to the personal information that you have seen as a result of a request for access and you are unable to make the changes yourself in your account, you may request that Allchiefs makes these changes for you. You may request that Allchiefs modifies, corrects, supplements, erases or shields your information.

### Restriction of processing of personal data

You also have the right, under certain conditions, to ask Allchiefs to restrict the processing of your personal data.

## Right to object

If processing of your data takes place on the ground of 'legitimate interest' by Allchiefs or a third party, you have the right to object to that processing.

#### Portability of data

You have the right to obtain your personal data from Allchiefs. Allchiefs will provide this in a structured and commonly used format, which can easily be opened using commonly used digital systems.

### Withdrawing consent

When the legal basis for a particular processing is your explicit consent, you have the right to withdraw that consent. This does not affect past processing, but does mean that we will no longer be allowed to process this data in the future. It may also result in Allchiefs no longer being able to provide you with certain services.

#### Response from Allchiefs

A request can be sent to josephine@allchiefs.nl. Allchiefs will comply with your request as soon as possible and in any case no later than one (1) month after Allchiefs has received such a request. If Allchiefs rejects your request, we will indicate in our reply why the request was rejected.

## Recipients of your personal data

Your data may be transmitted to Data Processors, such as:

- Our hosting provider (to host our website)
- Google (analytics)
- Mailchimp (to send you our newsletter)

It is possible that Allchiefs is required to submit your data to a third party, for example to fulfil a legal obligation.
